

This is regarding Compliance Reports submitted by JCT College of Engineering and Technology, Pichanur, Coimbatore-641 105, Tamil Nadu for the UG Engineering programs which were accredited by NBA in Tier-II for the academic years 2018-19 to 2020-21 and whose validity of accreditation is expiring on 30.06.2021.

2.
